 - 3) declare that I am the principal owner of the subject boat and I and my Insurer accept full responsibility for the Co-Owners as if I were the sole Owner of the boat, and
 - 4) agree that this agreement is in force from the date of the Club's acceptance of this Application until such time as it is expressly waived or discharged by the club, and
 - 5) commit to maintain Liability Insurance coverage for the term of this agreement and to the satisfaction of the Kingston Yacht Club.
